- end the practice of migrants being charged for NHS hospital services;
- end the sharing of patient data by the NHS with the Home Office, which can then be used for purposes of immigration control.

One of the first actions of our campaign has been to write to Council Leaders and Chairs of Health & Wellbeing Boards within Greater Manchester urging them to press the NHS Trusts in their borough not to implement migrant charges and Home Office reporting.

We have also called on our Greater Manchester MPs to support our action and to take up the campaign demands nationally.
